This Insurance is underwritten by 1Edge Insurance PCC Limited, acting on behalf of its cell, Cell 1 ("Insurer"). 1Edge Insurance PCC Limited and Stubben Edge (Risk) Limited are within the same wider company group but operate independently of each other in relation to Your Insurance.

From time-to-time Stubben Edge (Risk) Limited may earn commissions and share in profit from 1Edge Insurance PCC Limited but any determinations made in respect of this Policy are carried out by the 1Edge Insurance PCC Limited board independently of Stubben Edge (Risk) Limited to ensure that no influence or conflict of interests between Stubben Edge (Risk) Limited and 1Edge Insurance PCC Limited results in detriment to You in relation to this Policy. We may also earn income from Our third-party finance provider for arranging premium payment facilities. Using premium finance will make the overall cost of the Insurance more expensive. You may request details of any commission, fee or other renumeration payable to Us.

Please note that We have no contractual obligation to purchase Insurance products on Your behalf from 1Edge Insurance PCC Limited.

We have not provided any recommendation as to the cover You should take and the product has been selected by You based on the factual information supplied.

No. 2771296. 1Edge Insurance PCC Limited is a protected cell company with liability limited by shares incorporated in Guernsey under the Companies (Guernsey) Law, 2008, as amended (Companies Law).

1Edge Insurance PCC Limited is a company (company number 70415) incorporated in Guernsey whose registered office is Suite 1 North, 1st Floor Albert HoUse, South Esplanade, St Peter Port Guernsey, GY11AJ.
